Dear Dealer:

Enclosed is an application for a bourse table at the 2008 Convention. This is our 10th year at the same location with the same good food, YN program, Token & Medal Dealers, and the C4, NJES, and EAC meetings, all supported by our friendly staff of volunteers. Please read the following directions.

————— **Important. Please read.** —————

Last year's convention was very successful and completely sold out. In 2008 it is expected that the demand for tables could far exceed their availability.

We will follow these guidelines for allocating tables.

1. **If you had a table at the 2007 Convention**, be sure to send at least a **deposit by March 1** to hold the same table location. You will not lose your table or location unless you do not act by March 1, 2008
2. **If you did not have a table in 2007**, but would like one this year, please send in an application and a deposit. I will hold your check until I know if a table is available.
3. On March 1, I will assign any available tables to those new dealers who have sent a deposit.

If you had a table at any GSNA Convention since 1999, you need only sign the application and print the names you want on the dealer badges. The rest of the information is in our computer.

Bourse fees will be the same as last year. The GSNA is a non-profit organization run by volunteers.

Please help us by limiting your requests for badges to those dealers who will actually be setting up at your table. Early Bird Badges are available at a very reasonable cost of \$25, good for all 3 days.

Keep a copy of the contract so that you have all the details.

Location

Take Rt. 287 to Exit 10, go North on Rt.527, and turn left at the 1st light onto Davidson Ave. The bourse is in the Ukrainian Cultural Center, on the right side of Davidson Ave. There will be armed security present from 9 AM Thursday until 5 PM Saturday.

Hotel Reservations

The host hotel for the convention is the DoubleTree, located on the left side of Davidson Ave. just past the show site. The DoubleTree has reserved a limited number of rooms for us at a show rate of \$99. You must make your reservation before April 15, 2008 to take advantage of this special rate. Call the Doubletree at 800-554-3612 or 732-469-2600 and ask for the GSNA Convention rate.

Bourse Fees

In order to give dealers an opportunity to lower their costs, **cases and lamps are not included in the price of a table.** You will have a full 8 ft. table with backup space, or a corner with two 8 ft. tables and backup space. Tables will be assigned at the discretion of the show chairman.

Straight 8 ft. - \$350

Corner (two 8 ft. tables) - \$525

Deduct \$25 from the cost of any table paid for in full by April 1.

Cases and Lamps

For those dealers who need cases or lamps, the GSNA will provide them at cost. Quantities are limited, so reserve yours early.

Cases - \$12 each Lamps - \$6 each

Dealer Contract for GSNA Convention 2008 Agreement and Release

- 1) The Garden State Numismatic Association agrees to rent to the undersigned dealer bourse space at the 2008 GSNA Convention in Somerset, NJ.
- 2) Armed security guards will be present **from 9AM on May 15 until 5PM on May 17**. Please limit your presence to these hours. For your protection, please follow any directions of our security personnel.
- 3) The undersigned dealer and employees expressly releases the GSNA, their assistants, and their employees from any and all claims or responsibility for any and all personal and/or business losses, damages, or injuries that may occur from any cause whatsoever, prior to, during, or subsequent to the periods covered by this contract. The foregoing shall not limit liability of any individual personally guilty of theft, willful damage, or destruction.
- 4) The undersigned dealer agrees to abide by all rules and regulations of the Ukrainian Cultural Center, in particular their parking regulations and no smoking policy.
- 5) It is specifically understood that the GSNA is not an insurer and will not provide insurance to the dealer before, during, or after the show.
- 6) All New Jersey retail sales are subject to a 7% New Jersey sales tax. A New Jersey sales tax certificate can be obtained by calling 1-800-323-4400 in NJ, or 1-609-588-2525 outside NJ.
